- 6.14.12 The approximate requirement of Growth Hormone will be 10,000mg (30,000IU) for one year. Participant bidders can quote any strength, but should specify whether **IU** or mg and quote the rate per **IU** only in the price bid (BOQ) for evaluation. However the price bids will be evaluated on the basis of lowest rate quoted in the form of 1IU.
