The Price Bids (BOQ) submitted online in response to the e-tender referred 1<sup>st</sup> above for the Procurement of Specialty Drugs for the year 2024-25 were opened on **04.04.2024** and scrutinized. The Final bid status of the drugs tendered was published vide notice referred 2<sup>nd</sup> above deferring the status of 5 items for further negotiation.

**I. Items for which rates in the tender for the year 2024-25 are more than that available in the open market.**

The rates offered by the bidders in the tender for the year 2024-25 for the following 5 items are much higher than that in the previous year's/open market. Hence further negotiation was done online with those bidders to match/reduce their rate. During the online negotiation conducted none of the bidders have responded or have reduced their rates. **Hence offer of the following items is rejected.**
