# A. M/s. Meril Diagnostics Pvt Ltd

Rejected Model: Meriscreen Sickle Cell test/M/s. Meril Diagnostics

Reason for rejection: The offer was not considered as the sample test kits were unable to identify any of the positive cases as true positives.

B. M/s. Alpine Biomedicals Private Limited

Rejected model: Alpine Sickle Scan/Alpine Biomedicals

Reason for rejection: Specificity 90.67%

### C. M/s. ETHEREAL CARBON PRIVATE LIMITED

Rejected model: HEMOTYPESC TM, BLOOD LANCET, TEST TUBE, TEST TUBE RACK/SILVER LAKE RESEARCH

Reason for rejection: Not meeting the tender clause. "5.1.12 Minimum Average turnover for the last three completed financial years" - submitted only for 2 years.
