4. All materials before being incorporated in the work shall be inspected and if necessary tested before approval by the authorities. Any work on which such materials are used without prior inspection and without approval is liable to be considered as objectionable and not acceptable.
5. Works/supply shall be carried out without disturbing the existing buildings.
