SPECIAL CONDITIONS

- 1. The work location is adjacent to the KMSCL headquarters in Thycaud, Thiruvananthapuram. Before submitting a quote, the architecture firm must visit the proposed site and consult with KMSCL officials about the new Head Office building concept.
- 2. The architecture firm is liable to perform the work as per the quoted rate in preparing detailed floor-by-floor architecture 2D drawings with 3D views (minimum 4 views) of the proposed office building.
- 3. KMSCL invites Sealed quotations with Two Cover system (Cover I Prequalification cum Technical Bid Document, Cover II Commercial bid) are invited for the following work from Eligible Architect firm registered architect, LEED accreditation, Membership in professional organizations related to architecture or construction
- Cover 1 Copy of GST Certificate, Copy of PAN Card, Copy of License
- Cover 2 Commercial bid (Section IV: Price Bid)
- 4. The quotations shall be submitted in a single sealed cover with the superscription "Quotation No. KMSCL/Projects/Q/05/2024-25 For Quotation invited from Architect firms for Concept Drawing of KMSCL New Head office building, Thycaud, Thiruvananthapuram.
- 5. The name of the bidder with contact address and phone number shall also be written on the cover.
- 6. The sealed cover shall be submitted in favor of "The Managing Director, Kerala Medical Services Corporation Limited, Thycaud P.O, Thiruvananthapuram-14.
- 7. The last date and time of submission of Quotations shall be 09.09.2024 at 11.00 am .The quotations shall be sent by registered post or by courier or dropped in a box specifically kept at the KMSCL, Head Office, Thycaud, Thiruvananthapuram-14. The quotations obtained at the KMSCL, Head office shall be opened (technical bid only) at 2.30 PM on the same day in the presence of the Architect or their representative, who choose to be present, at that time.

- 8. The time of completion for the entire work is **45 days**. Rate quoted should be inclusive of all taxes.
- Time is the essence of the contract. The work has to be completed in 45 days time.
 Commencement of the work shall be considered from the 1st day on receipt of work order.
- 10. The work has to be completed and handed over by the end of 46 days from the date of commencement of work as per tender conditions. If the contractor fails to complete and hand over within the specified period, the penalty shall be charged at 0.5% of the contract amount per week of delay till it is handed over or till the penalty reaches 5% of the contract amount, after which the contract stand cancelled and the balance work will be arranged at the risk and cost of the Architect.
- 11. The Architect shall have valid GST Registration number. GST as applicable for the work will be paid by the KMSCL. The GST applicable as per law can be billed to the KMSCL, which will be paid to the Architect by the KMSCL along with the bills, for which the Architect shall hold valid GST Registration number.

The payment will be released by KMSCL only after the applicable statutory deductions

SECTION IV

SCOPE OF WORK

The scope of work for the concept of KMSCL's new head office building in Thiruvananthapuram is listed below.

- 1. Upon acceptance of the quotation, representatives from the selected architecture firm should visit the proposed location adjacent to the existing KMSCL Head Office. The architecture firm must consult with KMSCL officials about the concept of Head Office building, its requirements, and the functionality that should be included in the design.
- 2. Prior to beginning design work on the project, the architect firm will create a comprehensive architectural brief that includes project feasibility details as well as a thorough analysis of the build site.
- 3. The architecture firm must identify and detail any potential constraints within the proposed site. The team must design and develop the concept 2D drawing, which will include floor-by-floor design details as well as cabinetry and fittings suggestions throughout. Detailed design drawings must adequately break down costs, understand the scope of work, and finalise the look and feel of the concept building.
- 4. The architecture firm is liable to perform the work as per the quoted rate in preparing detailed floor-by-floor architecture 2D drawings with 3D views (minimum 4 views) of the proposed office building.
- 5. Based on KMSCL's requirements and needs, the architecture firm must design and construct the office building in accordance with the KMBR (Kerala Municipal Building Rule). The building design should incorporate the concept of KMSCL requirements in accordance with the KMBR rules and regulations.
- 6. KMSCL proposed to construct new head office building after the demolishing of old KSIHFW hostel building with the following facilities
