## **Technical Specification**

### **Equipment :Slit Lamp**

1. Magnification selection: 3 steps by rotation drum
2. Eyepiece: 12.5x/10x
3. Diopter adjustment:  $\pm 5D$  or better
4. Slit width: continuous from 0 to 14mm
5. Slit length: continuous from 0 to 14 mm
6. Aperture : continuous from 0 to 14mm
7. Slit angle :  $0^\circ$  to  $180^\circ$
8. Filter : blue, Red free
9. Light source :LED
10. Applanation Tonometer with accessories
11. Standard accessories and table
12. Should operate from 200 to 240Vac, 50 Hz input supply
13. Should provide suitable ups with 30 minutes backup
14. Should have safety certificate from a competent authority CE issued by a notified body registered in the European commission / FDA (US)/ STQC CB Certificate/ STQC S Certificate or valid detailed electrical and functional safety test report from ERTL. Copy of the certificate/ test report shall be produced along with the technical bid.

### **Note:**

1. If CDSCO (Central Drugs Standard Control Organization) certification is required for the import and marketing of the equipment, then the same shall be submitted along with the technical bid
2. Warranty exclusions if any shall be discussed at the time of prebid meeting else the tender condition as per clause 6.31.20 shall prevail
