I. Disposable Video Ureteroscope

- 1. Should be a flexible fiberoptic Uretero Renoscope with Continuous Irrigation.
- 2. Outer diameter of the shaft should be between 6 Fr. 10 Fr.
- 3. Should have an instrument channel between 3 Fr. to 4 Fr.
- 4. Should have 660mm ±20mm working length.
- 5. Should have a ceramic liner in the distal end of the working channel to protect it from thermal or electro Cautery damage.
