Other terms & conditions

1. The supplier shall execute an agreement with the purchaser as per tender conditions (agreement format is given in the tender document).
2. The supplier shall submit performance security amounting to 5.00% of the value of the supply order.
3. The labour & comprehensive charges of equipment after the completion of warranty period is finalized by KMSCL as mentioned above.
4. Since discount rate is not applicable for equipment under Running Contract of KMSCL, purchase/supply order can be issued directly to supplier at the given rate with tax & other charges (exclusive of KMSCL service charges).

5. If purchase/supply order is issued directly to the supplier, KMSCL service charge need not be paid. But the copy of the said order may be forwarded to KMSCL for information.

Technical Specification

Equipment :Dressing Trolley

1. Overall approximate dimension: 1000 mm L X 500 mm W X 900 mm H \pm 50 mm tolerance accepted.
2. Approximate shelf dimension: 750 mm L x 500 mm W.
3. S.S. tubular frame mounted on four 125 mm diameter castors with synthetic body, two with brake & two without brake.
4. Two S.S. shelves with protective railings on all four sides.
5. The sheets used shall be of 1.2 mm thick.
6. With S.S. bowl and S.S. bucket
7. Note : Material test certificate for the proof of SS 304 shall be furnished along with the invoice and the manufacturer shall also submit undertaking that the tested material is used for the construction of the equipment supplied

Note:

1. If CDSCO (Central Drugs Standard Control Organization) certification is required for the import and marketing of the equipment, then the same shall be submitted along with the technical bid
2. Warranty exclusions if any shall be discussed at the time of prebid meeting else the tender condition as per clause 6.31.20 shall prevail
