Other terms & conditions

1. The supplier shall execute an agreement with the purchaser as per tender conditions (agreement format is given in the tender

document).

2. The supplier shall submit performance security amounting to 5.00% of the value of the supply order.

3. The labour & comprehensive charges of equipment after the completion of warranty period is finalized by KMSCL as mentioned above.

4. Since discount rate is not applicable for equipment under Running Contract of KMSCL, purchase/supply order can be issued directly to supplier at the given rate with tax & other charges (exclusive of KMSCL service charges).

5. If purchase/supply order is issued directly to the supplier, KMSCL service charge need not be paid. But the copy of the said order may be forwarded to KMSCL for information.

Technical Specification

Equipment :Photo therapy unit double surface LED Type

- 1. Phototherapy should be based on advanced LED technology
- 2. In LED technology the irradiance should cover the entire treatment area of at least (50 x 25) cms.
- 3. Should have a height adjustable mechanism, treatment distance to the range of 25 to 45 cms should be possible.
- 4. Irradiance level should be 35 microwatts/cm2 at 35 cms or better distance.
- 5. Trolley should be mounted in 4 castor wheels with minimum 2 brakes and 3 castor wheels with minimum 2 brakes for upper surface unit
- 6. The irradiance should be measured and reported to the user institution at the time of installation and thereafter during every subsequent warranty/CMC/AMC visit and all breakdown visits.
- 7. Lamp source should be continuous tiltable to 45 degrees angle to cover the entire treatment area.
- 8. System should be height adjustable at least(110-160) cms from floor level with built-in non resettable timer
- 9. Baby bed should be transparent with up / down tiltable facility
- 10. Should work with input 200 to 240Vac 50 Hz supply.
- 11. Should have safety certificate from a competent authority CE issued by a notified body registered in the European commission /FDA (US)/ STQC CB Certificate/ STQC S Certificate or valid detailed electrical and functional safety test report from ERTL.Copy of the certificate/ test report shall be produced along with the technical bid.
- 12. The measurement of irradiance should be demonstrated to the technical committee during product demonstration
- 13. Should be supplied with 50 nos Eye masks along with the machine

Note:

- 1. If CDSCO (Central Drugs Standard Control Organization) certification is required for the import and marketing of the equipment, then the same shall be submitted along with the technical bid
- 2. Warranty exclusions if any shall be discussed at the time of prebid meeting else the tender condition as per clause 6.31.20 shall prevail
