- 1. Should have a micro motor with variable speed from 10,000 to 60,000 rpm
- 2. Should have at least four speed control modes
- 3. Should have an brushless dc motor for continuous high speed performance
- 4. Should have ON and OFF control for console and speed acceleration foot control
- 5. Should have integrated irrigation pump
- 6. Should be supplied with straight hand piece for micro motor and contra angle hand piece for micro motor
- 7. Should be supplied with the following Burs set
 - a. Tungsten carbide burs- 10 nos (Assorted size)
 - b. Diamond burs- 10 nos (Assorted size)
 - c. Steel cutting burs- 10 nos (Assorted size)
- 8. Should work with input 200 to 240 Vac 50 Hz Supply
- 9. Should have forward and reverse mode
- 10. Should have safety certificate from a competent authority CE issued by a notified body registered in European commission /FDA (US) /STQC CB certificate /STQC S certificate or valid detailed electrical and functional safety test report
