I. Micro pipette (variable volume)

1. Should have 4 digits volume display.
2. Should be a fully autoclavable type.
3. Control button shall be operated by very low operating force.
4. Ejector shall be operated by very low operating force.
5. Should be resistant to UV light.
6. All available volume ranges should be mentioned in the offer form.
7. Should have volume ranges of 0.5 - 10 µl, 2 -20 µl, 10-100 µl, 20 - 200µl, 100 - 1000, 500 -5000µl, 1000 -10000µl (The bidder can offer any other volumes available in the offer form)
8. Pipette should be IVD certified.
9. Bidders are requested to offer the rate of 1 pipette in the BoQ and this rate is applicable to all available pipette volumes
10. Price of 1 compatible pipette stands should be mentioned in the BOQ.
11. Cumulative rate of stand & pipette will be consider for L1 calculation
12. Should provide 3 year comprehensive warranty

II. Micro pipette – Fixed volume

1. Should be a fully autoclavable type.
2. Control button shall be operated by very low operating force.
3. Ejector shall be operated by very low operating force.
4. Should be resistant to UV light.
5. Pipette should be IVD certified.
6. All available volumes should be mentioned in the offer form.
7. Should have volume ranges of 10 µl, 20 µl, 50 µl, 100 µl, 200 µl, 25 µl , 250 µl , 500 µl ,1000 µl (The bidder can offer any other volumes available in the offer form)
8. Bidders are requested to offer the rate of 1 pipette in the BoQ and this rate is applicable to all available pipette volumes
9. Price of 1 compatible pipette stands should be mentioned in the BOQ.
10. Cumulative rate of stand & pipette will be consider for L1 calculation
11. Should provide 3 year comprehensive warranty
