- 1. Should have easy readable LCD display
- 2. Should have adjustable gain control
- 3. Should have a probe frequency of 10Mhz or more with internal fixation light
- 4. Should use immersion & contact measurement technique
- 5. Should have automatic, manual, PMMA, Silicone, Acrylic modes.
- 6. Should provide IOL formulas such as Holladay II, Hoffer Q, SRK/T, Haigis etc and should have accepted post refractive formulas like shammas or equivalent.
- 7. Should have a measurement range of 14 to 40mm or more
- 8. Should measure Anterior Chamber Depth, VCD, Lens thickness and axial length
- 9. Should have inbuilt thermal printer / external printer through USB/LAN
- 10. Should provide footswitch / automode, immersion cup, carry case and probe holder.
- 11. Should have LAN/USB/ RS232 Interface port connectivity
- 12. Should operate from 200 to 240V / 50 Hz power supply
- 13. Should have safety certificate from a competent authority CE issued by a notified body registered in the European commission / FDA (US)/ /IC-MED / STQC CB Certificate/ STQC S Certificate or valid detailed electrical and functional safety test report from ERTL. Copy of the certificate/ test report shall be produced along with the technical bid.
