Technical Specification

Equipment :OT light shadow-less ceiling mount double dome

- 1. Double dome ceiling type Operation Theater light shadow-less LED type
- 2. Light output should be minimum 1,20,000 lux at 1 meter distance for each dome.
- 3. Diameter of the dome should be less than 500mm.
- 4. Minimum light field size should be adjustable and range from 18 30 cm or better
- 5. Power supply to the lamp should be from a constant voltage source/SMPS.
- 6. Color temperature should be between 4000ËšK to 5000ËšK
- 7. Should have short circuit protection for the low voltage power supply
- 8. Colour rendering index should not be less than 95
- 9. Should have field focus control through sterile handle. Additional sterile handles two numbers should be supplied
- 10. All LEDs should be replaced free of cost during Warranty/ CAMC.
- 11. Minimum spring arm stroke of 500mm.
- 12. Minimum four step intensity control
- 13. Should have minimum action radius of 1500mm
- 14. Input supply 230Vac, 50Hz.

15. Should have safety certificate from a competent authority CE issued by a notified body registered in the European commission /

- FDA (US)/ BIS certificate. Copy of the certificate/ test report shall be produced along with the technical bid
- 16. Number of LEDs should be 24 or more in each dome.
- 17. Should have light intensity control.

18. Should have high performance LEDs with life time more than 40,000 hours
