## Equipment :Streak Retinoscope

- 1. Should have an external focusing sleeve which is easy to grip and manipulate.
- 2. Should have crossed-linear polarizing filter.
- 3. Should allow one-hand operation for streak focus and 360° streak rotation.
- 4. Should be interchangeable to plane mirror and concave mirror mode by sleeve movement
- 5. Should have halogen / LED light source.
- 6. Should have 100% dust proof housing and multi-coated optics.
- 7. Should have brow rest for spectacle wearer.
- 8. Should be rechargeable battery with Charger.
- 9. Should have a carrying case.
- 10. If halogen lamp is used, then the following additional accessories should be supplied.
