## Equipment: Flexible Ureteroscope

- 1. Should be a flexible fiberoptic Uretero Renoscope with Continuous Irrigation.
- 2. Outer diameter of the shaft should be between 6 Fr. 10 Fr.
- 3. Should have an instrument channel between 3 Fr. to 4 Fr.
- 4. Should have  $680mm \pm 20mm$  working length..
- 5. Should have a ceramic liner in the distal end of the working channel to protect it from thermal or electro Cautery damage.
- 6. Should have angle of view between 800- 900 field of view 00 with eyepiece adjustment.
- 7. Should have minimum angle of deflection 180 degree up, 270 degree down.
- 8. Should have active defection mechanism.
- 9. Should be supplied with gas sterilization valve.
- 10. Should be waterproof and fully immersible in solution.
- 11. Should be adhering to sterilization method with ETO, FO gas.
- 12. Should be supplied with the following accessories of compatible sizes.
- a. Grasping Forceps
- b. Biopsy Forceps
- c. Pressure compensation cap
- d. Leakage Tester
- e. Cleaning Brush
- f. Carry Case
- g. Access sheath

13. Should have safety certificate from a competent authority CE / FDA (US) / STQC CB certificate / STQC S certificate or valid
