Equipment : Argon Plasma Coagulation System with Cautery

- 1. The unit should be a microprocessor controlled 120 to300 watts class electrosurgery unit with argon plasma coagulation and suitable imported trolley.
- 2. Unit should have internal cooling system (no conventional external air cooling system).
- 3. The unit should have one bipolar socket compatible to connect accessories like gold and silver probe and one monopolar sockets so that one instrument can be connected and controlled from the sterile zone in a single program
- 4. The APC subunit should have one socket of APC
- 5. The unit should have two different fractionated cut modes for endoscopy and 4 different APC outputs
- 6. The unit should have plug and play option for APC instruments
- 7. The unit should give four modes of APC (micro, macro, pulsed high and pulsed low/ equivalent modes) with possibility to modulate flow and power settings
- 8. The unit should be supplied with three different type of flexible filter integrated plug and play applicator for different

endoscopic applications - Straight firing/ equivalent, conical firing/ equivalent, circumferential firing tip / equivalent

- 9. The unit should have bipolar cut mode and bipolar coagulation modes(Auto start and auto stop functions)
- 10. Type: protection classCF, class 1, IIb and the system should be CE and FDA approved
- 11. The unit should have continuous neutral electrode monitoring system and neonatal safety system for safer applications even with neonatal patients
- 12. The unit should have programmable facility for customizing minimum 15 programs
- 13. The unit should also be supplied with standard accessories such as:
- a. Two pedal foot switch with re mode.
- b. Universal adaptor
- c. Power cord

- d. Argon Cylinder 1 Nos (Preferably 2 cylinders)
- e. Argon regulator and sensor
- f. 1 monopolar cable compatible with the bronchoscope electrocautery snare unit.
- g. If any other accessories for making the unit completely functional

14. The rate 1 no of the following needs to be offered separately and the same shall be taken for L1 evaluation (Calculation shall doneautomatically by the BOQ).

- a. Patient plate disposable
- b. APC probes straight/ equivalent (Preferably 1 of the straight APC probes should be 1.5mm or more in external diameter if ordered more than 1 nos)
- c. APC probes conical/ equivalent
- d. APC probes circumferential/ equivalent

The rate for the Double Balloon Enteroscopy applicator shall be offered if available and the same shall not be taken for evaluation
