- 1. Should have 0-29 programmes.
- 2. Should have 2 separate output channels Channel 1 & Channel II.
- 3. Power shall be at least 46 watts.
- 4. Output current shall be 0-60mA

5. Output frequency shall be 4000Hz – 4250Hz for Channel 1 depending on the base and spectrum control & 2000 - 4000Hz (Constant) for Channel II.

- 6. Interference frequency shall be 0 Hz 100 Hz for Base & 0 Hz 150 Hz for Spectrum
- 7. Should have Front panel green Bar graph indicator for interference frequency indicator.
- 8. Should work with input 200 to 240Vac 50 Hz supply.
- 9. Should have safety certificate from a competent authority.
