## **Technical Specification**

## **Equipment :Otoscope**

- 1. Should be a C-Cell type or D-cell type Otoscope suitable for usage in outpatient departments of Govt. Hospitals.
- 2. Should be provided with a halogen/LED light source. In case of halogen light source, 2 Nos of spare bulbs are to be provided.
- 3. Should be able to detach the otoscope head.
- 4. Should provide no reflections and obstructions.
- 5. Should provide the following detachable accessories
  - 1. Specula (2.5mm to 5mm, 4 sizes)
- 6. Should have rechargeable battery. Charger for the Rechargeable battery shall be provided
- 7. Should have safety certificate from a competent authority CE issued by a notified body registered in the European commission / FDA (US)/ STQC CB Certificate/ STQC S Certificate or valid detailed electrical and functional safety test report from ERTL. Copy of the certificate/ test report shall be produced along with the technical bid

Note: If CDSCO (Central Drugs Standard Control Organization) certification is required for the import and marketing of the equipment, then the same shall be submitted along with the technical bid
