# **Technical Specification**

## **Equipment : Higher End Operating microscope for ENT with recording facility and monitor**

- 1. Compact Microscope body with 1:6 zoom ratio
- 2. Should have 5 or more step magnification changers with click stop positions
- 3. Should have total magnification ranging from at least 3.4x up to 21x or more without using additional magnification multiplier / changer.
- 4. All the Optical Components should be apochromatic corrected for all three basic colors.
- 5. Pair of high eye point wide field push-in eyepieces 12.5x magnification with eye guards and magnetic locks, dioptre setting from -5D to +5D, also suitable for spectacles wearers.
- 6. Field of view should be 112mm to 11mm continuously variable. Spot illumination should be motorized from 65mm 11mm continuously variable through effortless Single-Handed operation
- 7. Variable objective lens from 200mm to 400mm or more continuously manually variable, without changing front lens
- 8. Should have tiltable binocular tube with interpupillary distance adjustment varying from 55mm to 70mm or more
- 9. Should have integrated maintenance-free LED illumination providing Xenon like intensities at 5500K or more with lamp lifetime of 50,000 working hours or more
- 10. Should be floor standing type on castor wheels with brake
- 11. Should have coaxial illumination
- 12. Should provide intuitive balancing process allow smooth and effortless Single-Handed operation of the microscope
- 13. Should have a fully integrated 1-Chip Full HD (1080p) camera which can be trigger with the mode control knob through effortless Single-Handed operation on microscope or with remote control.
- 14. Should provide integrated Full HD-video (1080p) recording which can be stored on USB, triggered from microscope or with a remote control and simultaneously provide Full HD (1080p) live streaming without any external attachment.
- 15. The integrated recording system must provide HDMI output for displaying images/video during recording on to the Full HD 32" Display Monitor
- 16. Should be upgradable with assistant / teaching attachment with straight 90 degree straight binocular tube with Pair of high point wide field push-in eyepieces 12.5x magnification with eye guards and magnetic locks, diopter setting from -8D to +5D, also suitable for spectacles wearers
- 17. Should have rust free design
- 18. Should be supplied with sterilizable caps for adjustment knobs and handgrips.
- 19. When extended completely the total length of the arm from the stand to the microscope head should not be less than 1700mm.
- 20. The height of the floor stand should not be less than 1700 mm
- 21. Should be operated in 200-240 Vac 50/60 Hz input supply
- 22. Should be European CE approved

- 23. Should have Integrated red-free green filter for better visualization in blood filled operating field
- 24. Should have Integrated mode to better distinguish between vasculature and tissue especially for better visualization of Vocal cords
- 25. Should have Integrated mode to suppress the obtrusive reflections, allowing for a faster and more detailed distinction of anatomical details and artificial implants (critical).
- 26. Should provide Single-Handed operation for the activation of all visualization and recording modes
- 27. Should have provision for application-based interface for live streaming, capture and edit videos and images
- 28. Should be upgradable in future the ability to connect with hospital DICOM network for seamless transfer of data
- 29. Should provide interface for laser micromanipulator
