## **Technical Specification**

### **Equipment :Ultrasound Therapy with Electro Therapy**

1. It includes all electrotherapy currents and dual frequency ultrasound with combination therapy of two modalities that allows delivery of a full proof therapeutic treatment with the most advanced scientific insight. Electrotherapy waveform in combination with ultrasound provide effective pain reduction in minimum of time.
2. It should be able to provide treatment to two patients at a time.
3. It should have a constant current output
4. It should have dual independent electrotherapy channel
5. There should be a Hands free Sono applicator
6. There should be wide spectrum of waveforms
7. There should be preset protocols and therapeutic encyclopedia
8. There should be large 4-7'' touch screen.
9. The patient database should be stored.
10. There should be body parts navigation
11. It should be portable (battery operated- optional).
12. Should be provided with suitable trolley
13. Should have safety certificate from a competent authority CE issued by a notified body registered in European commission / FDA (US) / STQC CB certificate / STQC S certificate or valid detailed electrical and functional safety test report from ERTL. Copy of the certificate / test report shall be produced along with the technical bid.
