Technical Specification

Equipment : OT Table Orthopaedics (Motorized)

- 1. The table should have minimum 4 sections
- 2. The table should have a detachable split leg (560mm) and detachable head section (280mm).
- 3. The table top should be completely radiolucent made of bakelite.
- 4. The table top should have a minimum height of 765mm.
- 5. The table top should have a minimum vertical stroke of 300mm
- 6. Should have at least 25° trendelenburg or reverse trendelenburg
- 7. Should have at least 20° lateral tilt movement
- 8. Should have at least 80° back up movement
- 9. The head section should have up and down movement manually
- 10. Should have seven functions motorized and achieved by corded hand with controlled efficient Electromechanical System (Up, Down, Trendelenburg, Reverse Trendelenburg, Right Lateral tilt, Left Lateral tilt, B-Chair)
- 11. The Knee Chest or jack knife position should be achieved manually.
- 12. The table should have a heavy and sturdy base and compact to provide adequate foot room for the operating team.
- 13. The table should be mounted on heavy duty casters which offer enhanced weight bearing capacity and free mobility.
- 14. The table should have a single lever foot operated brake pedal
- 15. Should have a minimum patient weight bearing capacity of 175 Kgs.
- 16. Base should be made of cast Iron and all other parts and accessories should be completely made up of stainless steel.
- 17. The size of the main central column should be smaller to offer higher c-arm access.
- 18. The table should be compatible for spine surgeries with C-arm or separate accessory should be provided for doing spine surgery with C-arm.
- 19. The pelvic support should be movable to the edges and completely radiolucent.
- 20. The perennial post should be completely radiolucent
- 21. The up/down and trendelenburg and reverse positions are achieved by German make high torque DC Motors mounted to a highly efficient German telescopic linear drive and can be operated by corded hand switch.
- 22. The B-Chair and lateral tilts are achieved by German make actuators with integrated motors and can be operated by remote or corded hand switch.
- 23. The table should be supplied with the following accessories.
 - a. Mattress for the complete table top in sections 1 set
- b. A pair of arm boards with pad and fixing clamp 1
- c. A pair of padded shoulder support with clamps 1
- d. A pair of padded lateral support with clamps 1
- e. A pair of leg crutches with clamps 1
- f. Anesthetic screen frame with clamp 1
- g. Adjustable traction device with minimum leg stroke of 175mm
- h. Should have accessories for tibia interlocking.
