- 2.The quantities provided in the estimate are reasonably correct as per the assessment made.On actual execution,the quantities may vary by increasing or decreasing to the actual requirement.The contractor is liable to execute the work to the actual requirements of quantities.
- 3.The contractor has to provide all materials for the execution.Corporation does not take responsibility of supplying any material.The rate quoted shall be including all costs.
- 4.All materials before being incorporated in the work shall be inspected and if necessary tested before approval by the Authorities.Any work on which such materials are used without prior inspection and without approval is liable to be considered as objective and not acceptable.
- 5.Works shall be carried out without disturbing the existing tiled/finished surface.
- 6.Any defects occurs on the existing surface will be replaced the contractor at his own cost.
- 7.The quotations shall be submitted in a single sealed cover with the superscription "Quotation No.KMSCL/Projects/Quot/007/2018-2019,dated 27/07/2019, For the Vitrified Flooring work at Ground floor damaged area at District Drug Warehouse, Alappuzha.The name of the bidder with contact address and phone number shall also be written on the cover.

- 9.The last date and time of submission of Quotations shall be **2/08/2019, 2.00 pm**.The quotations shall be sent by registered post or by courier or dropped in a box specifically kept at the KMSCL,Head Office,Thycaud,Thiruvananthapuram-14.The quotations obtained at the KMSCL,Head office shall be opened at **2.30 pm on the same day** in the presence of

the contractor or their representative, who choose to be present, at that time. The L1 list will be announced and published on the same day.

10. The agreement has to be executed by the L1 bidder in the prescribed form on stamp paper of value Rs.200/- purchased in the Kerala State.

11. The time of completion for the entire work is 21 days. Rate quoted should be inclusive of all taxes.

12. Quality of materials should be got approved from the quotation/tender inviting authority before supply of materials.

13. The contractor should co-operate with other contractors working at the site.

14. Time is the essence of the contract. The total work has to be completed in 21 days time. Commencement of the work shall be considered from the 1st day of receipt of work order or date of handing over of hindrance free site from client.

15. The work has to be completed and handed over by the end of 21 days from the date of commencement of work as per above conditions. If the contractor fails to complete and hand over the building within the specified period, the penalty shall be charged at 0.5% of the contract amount per week of delay till it is handed over or till the penalty reaches 10% of the contract amount, after which the work order stand cancelled and the balance work will be arranged at the risk and cost of the contractor.
