Other terms & conditions

Technical Specification

Equipment :Sternal Saw

1. Charger unit should have facility for charging 4 batteries at a time.
2. Sternal Saw Hand piece
 - a. Reciprocating blade type
 - b. Should be autoclavable
 - c. Light weight
 - d. Blades – 5 Nos
3. Resternotomy Saw Hand piece
 - a. Oscillating blade type

- b. Sector type blade
- c. Should be autoclavable
- d. Blades – 2 Nos
- 4. Should be supplied with tool kit and special container for the system.
- 5. Should have blade guard.
- 6. Extra set of Sternum Saw blade (set of 5).
- 7. Should be supplied with 2 large Li-ion batteries and 2 small Li-ion batteries
- 8. Should have safety certificate from a competent authority CE issued by a notified body registered in the European commission / FDA (US)/ STQC CB Certificate/ STQC S Certificate or valid detailed electrical and functional safety test report from ERTL. Copy of the certificate/ test report shall be produced along with the technical bid
