Technical Specification

Equipment :Wall Mounted Spot Light â€“ LED Adjustable

1. Should be wall mounted spot light.
2. Should be able to adjust position.
3. Should use a LED light source.
4. It should have minimum light intensity of 50,000 lux at 30 cm.
5. CRI should be minimum 90.
6. It should have field size of at least 10 cm at a distance 30cm from the light head.
7. It should have on/OFF switch on light head handle.
8. Color temperature should be 4000K-5000K.
9. Should have an arm length of at least 36”.
10. Arm and head should be adjustable horizontally and vertically.
11. Powers supply should be SMPS.
12. It should be CE/FDA certified.
