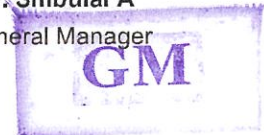

SPECIAL CONDITIONS

1. The location of work is as noted in the schedule. The contractor has to visit site before quoting and interact with our representatives or Engineers of consultants and study all the requirements.
2. The quantities may vary by increasing or decreasing to the actual requirement. The contractor is liable to execute the work to the actual requirement of quantities.
3. The contractor has to provide all materials for the execution. Corporation does not take responsibility of supplying any material. The rate quoted shall be including all costs (including Transportation, loading and unloading).
4. All materials before being incorporated in the work shall be inspected and if necessary tested before approval by the Authorities. Any work on which such materials are used without prior inspection and without approval is liable to be considered as objective and not acceptable.
5. Kmscl invites sealed quotations with Two Cover system (Cover I Prequalification cum Technical Bid Document, Cover II Commercial bid) are invited for the following work from Eligible contractors /Registered Bidders of Kerala.
6. Cover 1 – Copy of GST Certificate, Copy of PAN Card, Copy of License, Bank details – Banker's name & address and details of Bank Account Number of the bidder. Cover 2 - Commercial bid (Section I V: Schedule of quantity)
7. The quotations shall be submitted in a single sealed cover with the superscription

8. The name of the bidder with contact address and phone number shall also be written on the cover.
9. The sealed cover, shall be submitted in favour of “The Managing Director, Kerala Medical Services Corporation Limited, Thycaud P.O, Thiruvananthapuram-14.
10. The last date and time of submission of Quotations shall be 09.12.2024 at 2.00 pm. The quotations shall be sent by registered post or by courier or dropped in a box specifically kept at the KMSCL, Head Office,Thycaud,Thiruvananthapuram-14.The quotations obtained at the KMSCL, Head office shall be opened at 2.30 PM on the same day in the presence of the contractor or their representative, who choose to be present, at that time. The L1 list will be announced and published on the same day.
11. Electric power for the work has to be arranged by the contractor.

12. Time is the essence of the contract. The work has to be completed in 45 days time. Commencement of the work shall be considered from the 1st day on receipt of work order.
13. The work has to be completed and handed over by the end of 46 days from the date of commencement of work as per tender conditions. If the contractor fails to complete and hand over within the specified period, the penalty shall be charged at 0.5% of the contract amount per week of delay till it is handed over or till the penalty reaches 5% of the contract amount, after which the contract stand cancelled and the balance work will be arranged at the risk and cost of the contractors/Registered Bidders.
14. The Contractors/Registered Bidders shall have valid GST Registration number. GST as applicable for the work will be paid by the KMSCL. The GST applicable as per law can be billed to the KMSCL, which will be paid to the contractors/Registered Bidders by the KMSCL along with the bills, for which the shall hold valid GST Registration number.

The payment will be released by KMSCL only after the applicable statutory deductions

15. Schedule of Payments :

Stage wise payment as per quoted rate in each stage as mention below

1. 95% Final bill amount will be released to contractor after checking the site measurements and submission of product Warranty/Guarantee in bidder's letter head.
2. Balance 5% amount will be released to contractor after three months from the date of work completion and hand over to KMSCL authorities.
3. 5% Retention amount to be deducted on each running bill and the retention amount will be released only after the defect liability period as per the G.O.(P) No.161/2019/Fin dated 25.11.2019
