6. Any defects occurs on the existing surface will be replaced the contractor at his own cost.

10. The time of completion for the entire work is 21 days. Rate quoted should be inclusive of all taxes.

11. Quality of materials should be got approved from the quotation/tender inviting authority before supply of materials.

12. The contractor should co-operate with other contractors working at the site.

13. Time is the essence of the contract. The total work has to be completed in 21 days time. Commencement of the work shall be considered from the 1st day of receipt of work order or date of handing over of hindrance free site from client.

14. The work has to be completed and handed over by the end of 21 days from the date of commencement of work as per above conditions. If the contractor fails to complete and hand over the building within the specified period, the penalty shall be charged at 0.5% of the contract amount per week of delay till it is handed over or till the penalty reaches 5% of the contract/value of executed amount, after which the work order stand cancelled and the balance work will be arranged at the risk and cost of the contractor.
