### SECTION II SPECIAL CONDITIONS

- 1. KMSCL invites NIQ for the Annual Maintenance Contract of DG Sets from OEM's (Original Equipment manufacturers) or Experienced and authorized service providers of the OEM of various DG sets.
- **2.** Only those bidders having valid authorization certificate in Service and maintenance of DG sets from OEM's can participate in the quotation
- **3.** The Contract entered is valid for the Diesel Engines (Leyland), Stamford Alternator, Control panel and all DG components
- **4.** Service Dealer will visit the customer 06 times a year and will carry out preventive maintenance of engine as per the requirement.
- **5.** Any breakdown will be attended free of cost within 6 hours time. However, it does not cover major failures like Engine Overhauling, Main Alternator Overhauling and local repairs of Fuel Pump, Battery charging, Alternator, Self Starter and Radiator etc.
- **6.** All spare parts required for carrying out the preventive maintenance and break down will have to pay by the customer
- **7.** The customer shall pay for the consumables like diesel, oil, cleaning agents etc. The payment against the same shall be settled only after submitting the original GST bill of the spares
- **8.** 0.5% of the contract value per day will be leaved for every late attend beyond 24 hours subject to a maximum of 10%.
- **9.** All materials before being incorporated in the work shall be inspected and if necessary tested before approval by the authorities. Any work on which such materials are used without prior inspection and without approval is liable to be considered as objective and not acceptable.
- **10.** The quotations shall be submitted in a single sealed cover with the superscription "Quotation No. KMSCL/Projects/Quot no 71/2025-2026/dated **31/10/2025** for AMC of DG Sets at various locations. The name of the bidder with contact address and phone number shall also be written on the cover. Bidder should furnish price bid, declaration form and comparative statement along with quotation document.

#### **SCOPE OF WORK**

The AMC will be purely plain labour contract on which the periodic preventive maintenance and attending breakdown shall be arranged through the successful bidder (shall be an Engine manufacturer /Authorized Dealers of its Engine manufacturer available in the state who can provide better service and attend the breakdowns in a short span of time) and the cost applicable on spares will be borne by the NIQ Authority or the user institutions, as the case may be. During the period of AMC. In short, the AMC is a CMC with provisions for payment of cost of spare parts during the period of contract by the Quotation Inviting Authority or User Institution as the case may be. The AMC contract shall include:-

- 1. Check Lube Oil level and condition of lube oil sump.
- 2. Check coolant level in the radiator/ Heat Exchanger.
- 3. Check for any oil leakage
- 4. Check for any Coolant leakage.
- 5. Check all rubber hoses, fuel, lub oil, water, air filter including HP pipes, replace if necessary.
- 6. Check all Y Belt condition and tension, replace/re-tension if necessary.
- 7. Check Diesel Tank/Diesel Pipe/Diesel Filter, Clean/replace if necessary.
- 8. Check and adjust valve clearance
- 9. Check all external fasteners for tightness.
- 10. Check the coupling condition and tightness of coupling bolts.
- 11. Check battery Electrolyte level and terminal condition, Refill, apply petroleum jelly if required.
- 12. Check electrical connection of engine panel board
- 13. Start the engine, test on available load (if application permits) and record all parameters.
- 14. K-Oil & Filter to be change at 400 hours or 6 months whichever is earlier
- 15. Checking of main Alternator cable connections, AVR fault diagnosing, winding and cleanliness of alternator component.
- 16. Checking of main Alternator running parameters, like voltage and current
- 17. Check for control panel, checking of Switches, push button, wiring harness, fuses, and gauges, meters, MCB/MCCB/ACB, coils and indicating lamps.
- 18. Repairs of door locks, hinges, acoustic foam.
- 19. 0.5% of contract value will be levied per day for every late attend beyond 24 Hrs subject to maximum of 10%
