The GST values (CGST, SGST and IGST) entered by all the bidders were compared with the GST % and GST value automatically generated in the Price Bid submitted (BOQ) and variations noted were corrected with actual GST%, and GST values and landed price in the Price Bid (BOQ) submitted is revised accordingly (with the actual GST% in the price breakup) without any change in the Basic price offered.

It is found that there is variation in the GST % offered by the following bidder with that of available records. Hence the rate of quoted products is re-fixed by the Corporation as per Clause no: 6.10.10 of the tender.
