As per ref. 1st cited, Kerala Medical Services Corporation Ltd. (KMSCL) invited tenders through the e-tender portal for the selection of a Chartered Accountant firm to conduct the internal audit for the financial years 2020–21 to 2024–25. The scope of work listed in the tender was to engage the firm to provide the following services to the Corporation :-

1. Ledger Scrutiny, closing of Books of Accounts with necessary closing/accounting entries in adherence of Income Tax Act, Companies Act, GST Act etc.
2. Preparation of Financial Statements as per Companies Act.
3. **Audit should be completed by 31-03-2026, and to be submitted before the Statutory Auditor for the speedy completion of the Statutory Audit from 2020-21, 2021-22, 2022-23, 2023-24, 2024-25.**
4. Suggestions for improvement in accounting, following rules, dealing with taxation matters, awareness about accounting standards, laws prevailing and amendments introduced by Government from time to time etc.
5. Any delay in completion of the assigned work beyond the stipulated timeline shall attract a penalty, which may be levied at a rate specified by the department or as decided by the competent authority, depending on the extent of delay and the reasons thereof.

As per the tender conditions, the amount quoted in the Price Bid is **for the completion of the entire audit work**, i.e., for timely completion of the audits for the financial years **from 2020–21 to 2024–25** and submission of the audit reports on or before 31-03-2026.
