1.The representation submitted by M/s.Blaze Systems and Services states that"This has reference to the demonstration carried out by us on account of tender " Multiparameter monitor (5 para) with central station. We have been intimated vide your letter No KMSCL/EP/10408/2024 that the CE certificate submitted by us is invalid and unverifiable. We would like to respectfully bring to your attention that the submitted CE certificate is indeed valid and can be verified through the official European Commission portal. The notified body is SGS Belgium and the notification body number is 1639.

2. The representation submitted by the bidder is verified with the European date base medical devices.The committee convinced that the certificate submitted by the bidder is valid and can be acceptable. Hence the representation can be considered and the offered model of M/s.Blaze Systems and Services "C80/Shenzhen Comen Medical" is selected for pricebid opening.
