The Price Bids (BOQ) submitted online in response to the e-tender referred 1st above for the Procurement of Drugs (Category I & II) for the year 2025-26 were opened on **09.04.2025** and evaluated.

The final Bid Status of the same was published vide notice referred 2nd above.

1. *“With respect to the blacklisting of M/s. Nandani Medical Laboratories Pvt Ltd by Madhya Pradesh Public Health Services Corporation Ltd, the qualification of the rate offered by M/s. Nandani Medical Laboratories Pvt Ltd is considered only for bid ranking status. The qualification of the firm for Award of Contract may be decided only if appropriate orders are passed from the Hon’ble High Court, prior placement of LOI against the e-tender.*

- If in case, the Court order is not produced prior placement of LOI, procurement of the 18 items will be initiated with other eligible bidders for 40% of the tendered quantity for which M/s. Nandani Medical Laboratories Pvt Ltd is the L1.*

- *In case of 7 items where M/s. Nandani Medical Laboratories Pvt Ltd is the single bidder, then the possibility of getting the items through re-tender will be explored”.*

M/s. Nandani Medical Laboratories Pvt Ltd yet not submitted favorable order from the Hon. High Court till date in this regard. **Hence offer of the firm for the following items is rejected.**
