- 3. Objectives Parfocal, antifungus coated 4x, 10x, 40x and 100x (oil immersion) with plan achromatic correction for FOV of 20 mm.
- 4. Optical system Infinity corrected
- 5. Stage Horizontal mechanical stage minimum 100 x 140 mm with fine vernier graduations designed with convenient coaxial adjustment for slide manipulation preferably through 30 x 70 mm.
- 6. Substage Abbe condenser N.A 1.25 focusable, continuously variable iris diaphragm
- 7. Illuminator Built-in LED light source with white light with rechargeable battery backup.
