- 1. Over all approximate size 1890mm Lx 560 mm W x 840mmH.
- 2. Fixed upholstered top in two pieces of 56mm width, Rexin shall be of good quality, Mattress shall be PU form of density 50.
- 3. Thickness of sheets shall be 1.2mm. Thickness of frames shall be 2mm.
- 4. Head rest adjustable on gas spring
- 5. Upper section of box with three drawers
- 6. BP apparatus tray provided near head rest
- 7. Should provide foot step
- 8. Pre-treated and powder coated
- 9. Lower section below the drawers should have storage facility with hinged doors.
