## **Technical Specification**

**Equipment Name: OT light LED with Camera** 

- 1. Should be a Surgical Light unit incorporating the latest LED technology shadowless operating light field with the following specifications.
- 2. Should have high performance LEDs with life time more than 40,000 hours.
- 3. Should be a dual dome and the main light and satellite should have the following specifications
- a. LUX intensity 1,60,000 Lux & Satellite 1,60,000 Lux or above, uniformly throughout the surgery.
- b. Light Field diameter should be adjustable and range from 18-30cm or better
- c. Colour temperature should be variable between 3600 to 5000 degree K (Tolerance+200k)
- d. Colour rendering index should not be less than 95
- e. Depth of illumination should not be less than 100 cm.
- f. Illumination adjustment 30% to 100%
- g. The light dome shall be compatible for laminar air flow. Certifications shall be attached with the technical bid.
- 4. Should have stable illumination throughout the life period of the light. If the intensity reduces during the warranty or CMC period the LEDs has to be replaced at free of cost if required.
  - 5. The LED's must be suitable for long term maintenance and ease of replacement.
  - 6.Temperature rise at the surgeon head level should be less than 2 degree C.

- 7. Should have control panel for light focusing adjustment fixed on the dome or arms or touch screen.
- 8. Should supply autoclavable handles 6 Nos for each dome.
- 9. The intensity of light should be uniform during the surgery.
- 10.Minimum spring arm stroke of 500mm and minimum action radius of the complete arm shall be1500mm or more.
- 11.One of the dome should have detachable camera with the following specification;

High definition 1080 lines resolution camera with optical zoom and focus adjustment. The camera control functions shall be either with remote control / wall control panel / dome / arm. The output of the camera shall be taken out and connected to the monitor / TV provided by the user institution (Maximum distance: 100meters). The rate of camera shall be quoted separately which will be taken for evaluation.

- 12. The rate for third arm with monitor attachment and rate for third arm with camera, if available shall be provided. Cost will not be taken for evaluation.
  - 13.Cost of 32inches HD LED TV shall be quoted separately and will be taken for evaluation.
  - 14.Unit should function with 200-240Vac, 50/60 Hz input power supply.
- 15. Should have safety certificate from a competent authority CE issued by a notified body registered in European Commission / FDA (US) / STQC CB certificate / STQC S certificate or valid detailed electrical and functional safety test report from ERTL. Copy of the certificate / test report shall be produced along with the technical bid
  - 16.All arms and light head should have 360 degree movement. The dome shall be mounted on cardanic arms.
  - 17. Should have 48 LED in each dome.
