A. OPTHALMIC OPERATION TABLE MOTORISED

- 1. Should be motorized table with ophthalmic head piece and adjustable wrist support.
- 2. Should have operated on foot-pedal control for up and down movements.
- 3. Should provide with antibacterial, dis-infectable mattress.
- 4. Locks to stabilize when in use with high quality rust-proof castors.
- 5. Should have table top movements essential for ophthalmic surgery.
- 6. The table should have trendelenburg and reverse trendelenburg movement
- 7. Should be made of SS-304 grade

A. SURGEON'S CHAIR(Motorised)

- 1. Should have motorized up and down movement
- 2. Should have foot operated control.
- 3. Should have an adjustable back support.
- 4. Should have height adjustable / detachable arm rests.
- 5. Should be made up of SS304 Grade completely with upholster seat, back rest and arm rest
- 6. Minimum height should be 20" and maximum should be 28".
- 7. Should have full swivelling castors for easy mobility. Castors with brake.
